- 5. Applicant, who accepts the study place under the SSSDP is not eligible for the non-means tested annual subsidy of \$30,000 provided by the Government.
- 6. Applicant, who is an awardee of THEi Entrance Scholarship (except LA, HLM and CAM programmes) or Achievement Scholarship in Academic Year 2017/18, will forfeit the scholarship payment offered by the Institute, if any, upon acceptance of a study place under the SSSDP.

Tuition fees are charged according to the number of credit points taken in a semester. The tuition fee for 2017/18 academic year is set from \$2,250 to \$2,930 per credit point. Students have to complete a minimum of 132 credit points for graduation. Tuition fees are subject to annual review.

The subsidy will be administered by a two-tier arrangement in which a subsidy of up to \$40,000 per academic year is provided to programmes which are not laboratory-based while a higher subsidy of up to \$70,000 per academic year is provided to more costly programmes which are laboratory-based.
