4. The admission scheme is not applicable to non-local students.
5. Applicant, who accepts the study place under the SSSDP is not eligible for the non-means tested annual subsidy of \$30,000 provided by the Government.
6. Applicant, who is an awardee of THEi Entrance Scholarship (except LA, HLM and CAM programmes) or Achievement Scholarship in Academic Year 2017/18, will forfeit the scholarship payment offered by the Institute, if any, upon acceptance of a study place under the SSSDP.

Students have to complete a minimum of 132 credit points for graduation. Tuition fees are subject to annual review.</p> <p>The subsidy will be administered by a two-tier arrangement in which a subsidy of up to \$40,000 per academic year is provided to programmes which are not laboratory-based while a higher subsidy of up to \$70,000 per academic year is provided to more costly programmes which are laboratory-based.
