**Pilot Scheme for Admission of Graduates from
the Diploma of Foundation Studies (DFS)**

To provide a fast track degree articulation pathway to deserving DFS graduates, THEi will introduce a pilot scheme for admission of DFS graduates to Year-1 of its degree programmes in the 2023 Admission Exercise. Subject to the admission quota, DFS students who fulfil the following requirements upon graduation might be given a degree study place in THEi:

1. a distinction award in the DFS;
2. a Level 3 in English Language in the HKDSE; **or** possession and passed five specific VTC's Vocational English Modules Certificates, with at least two Level 2 Modules at Grade B and two Level 3 Modules at Grade B; or equivalent results; and
3. if the degree programme concerned is offered by THEi's Department of Construction Technology and Engineering, either have (i) a Level 2 in Mathematics in the HKDSE; **or** (ii) successfully completed the DFS optional module "Foundation Mathematics III".

You are now cordially invited to express your interest in being considered for direct admission to THEi's degree programme by completing and returning the attached reply slip to THEi Faculty Office concerned **on or before 30 June 2023 (Friday)**. Results of this Pilot Scheme will be announced in July 2023 and students to whom a firm offer is given will be notified individually (the offering of study place is subject to the admission quota of the degree programme concerned). To facilitate our processing, your personal data, academic results related to your current and previous study in the VTC will be used by THEi and the VTC in assessing your eligibility for direct offer of a degree study place and other related purposes.
