1. Please read the programme entrance requirements before completing the application form.

The original academic transcript(s)/certificate(s) and proof of employment must be produced for verification on submission of the application form. A passport photo should be stuck on the application form for the production of Student Identity Card. Printed versions are not accepted. Late submission of passport photo may lead to late collection of Student Identity Card.
3. Please return the completed application form to the Registry **in person** together with a **crossed cheque** in the amount of **HK\$50,800** and payable to “**Vocational Training Council**” or “**職業訓練局**”. The total programme fee is HK\$86,400 payable by two instalments. The **first instalment (HK\$50,400)** and the **caution money (HK\$400)** are to be settled upon submission of the application form **on or before 31 August 2021**. The second installment (HK\$36,000) shall be paid **on or before 31 July 2022**. A student who officially completes or withdraws from a programme will be eligible for the refund of the caution money paid, if he/she has no outstanding fees and charges due to the Institute. A refund cheque, if applicable, will be mailed to the student at the correspondence address provided on the application form upon completion of the programme or approval of the withdrawal. **The tuition fee paid is normally not refundable and not transferable, except for the cases of unsuccessful applications and course cancellation.**
